January 2020

Updating of the SVHC (substances of very high concern) Candidate List

June 2023

Updating of the SVHC (substances of very high concern) Candidate List

The update to the Substances of Very High Concern (SVHC) Candidate List has resulted in the identification of additional substances subject to declaration requirements. Following this update, only the specified articles in our list of declarable ORGATEX products are affected. This update is in accordance with "Regulation (EU) 2023/1132 of June 8, 2023, amending Regulation (EC) No 1907/2006 concerning carcinogenic, mutagenic, or reproductive toxic substances subject to restrictions.
